## CHRISTOPHER B. CURTIS '79 (CHAIR)

Christopher B. Curtis '79 is currently executive chairman for private-equity-owned Mission Critical Group, an electrical equipment engineering, manufacturer and professional services firm. Curtis is also an independent board director for the Canadian Standards Association and S&C Electric Company, where he chairs the Human Resource and Compensation Committee and is a member of the Governance Committee.

From 2016 to 2020, Curtis served as chief executive officer of the Wencor Group, an Atlanta, Georgia, based supply, distribution and service company to the aerospace industry. He also served as chairman of Munters AB (NASDAQ: MTRS.ST), a Swedish-based global leader in air treatment solutions from 2014 to 2018. From 2014 through 2016, Curtis served as a non-executive director on the public company boards of Kimball Electronics and Aegion.

Curtis is perhaps most well-known for his work at the \$30 billion-plus French multinational Schneider Electric. From 2008 to 2013, he served as president and chief executive officer of Schneider Electric North America. Under his leadership, Schneider Electric North America's sales topped \$7 billion. Curtis' experience with Schneider Electric spanned two decades as he oversaw all operations in the United States, Canada and Mexico. He was a member of the corporate executive committee and, from 2008 to 2012, he also led Schneider Electric's Buildings Business, valued at \$2 billion globally.

He has extensive strategic and operating experience in general management, business transformation, mergers and acquisitions, industry/government affairs, investor relations, sales/marketing, services and operations. Prior to his role leading Schneider Electric, Curtis was president, Schneider Electric USA, president of Schneider Electric Canada, senior vice president of sales and services, and vice president of marketing for the company's North American operating division.

A graduate of Le Moyne College, Curtis has also studied at both the Harvard Business School and Guanghua School of Management in Beijing. He was an executive adviser for the Farmer School of Business at Miami of Ohio University from 2008-2016 and was the chairman of the National Electrical Manufacturers Association in 2014. He was recognized with the industry's highest honor, the Bernard Falk Award, in 2016.

Michael Corasaniti is the chief executive officer of Tourmalet Advisors L.P. Before forming Tourmalet Advisors, Corasaniti served as president and chief investment officer of Pequot Capital Management Inc. in New York, New York. Before joining Pequot in September 2003, Corasaniti was executive vice president and director of research at Keefe, Bruyette & Woods Inc. Previous to Keefe, Bruyette & Woods, Corasaniti was a managing director at Neuberger Berman, where he was the co-manager of a \$3 billion equity fund. Corasaniti joined Neuberger Berman as a financial services industry analyst in 1995 from Alex Brown & Sons, where he was the specialty financial services industry analyst, focusing on mortgage lenders, automobile finance firms and non-bank commercial finance companies.

Early in Corasaniti's career he was a retail stockbroker at Prudentia-Bache, a mortgage-backed securities salesman for Meridian Bancorp and an analyst at Bear Stearns.

## KATHLEEN (KATHY) FORBUSH '90 (SECRETARY)

Kathleen (Kathy) Forbush '90 is the executive director for talent management at Johns Hopkins University. Johns Hopkins is a private research university organized into 10 divisions on campuses in Maryland and Washington, D.C., with international centers in Italy, China and Singapore, and a total enrollment of 24,000 undergraduate and graduate students, and more than 19,000 employees.



Audi and her late husband, Alfred, have three children, Edward, Carolyn and Andrea, and four grandchildren.




## ERICK BERRELLEZA, S.J.

## JEANETTE J. EPPS '92

Jeanette J. Epps '92 recently retired as a NASA astronaut, after 16 years with the administration. Epps was selected to join NASA in 2009 as a member of its 20th astronaut candidate class. Among the highlights of her career was a six-month trip to the International Space Station. While waiting for that assignment, Epps served as a representative of the Generic Joint Operation Panel working on crew efficiency on the space station (as well as other topics) and served as a crew support astronaut for two expeditions.

Before joining NASA, Epps spent more than two years working at Ford Motor Company as a technical specialist in the Scientific Research Laboratory and more than seven years at the Central Intelligence Agency as a technical intelligence officer.

The Le Moyne alumna received the NASA Graduate Student Researchers Program Fellowship in 1996, 1997, 1998 and 1999. She was inducted into the University of Maryland, Department of Aerospace Engineering, Academy of Distinguished Alumni in 2012. She was presented with the Johnson Space Center Director's Innovation Group Achievement Award to Improve Efficiency on the ISS Team in 2013 and was the recipient of the Glenn L. Martin Medal from the A. James Clark School of Engineering, University of Maryland in 2014.

Epps earned a bachelor's degree in physics from Le Moyne College in 1992 and a master's degree and doctorate in aerospace engineering at the University of Maryland in 1994 and 2000 respectively. She returned to the Heights in 2016 to deliver the College's commencement address and was presented with an honorary doctorate from Le Moyne College.

## PHILIP A. FLORIO, S.J.

Philip A. Florio, S.J., was born and raised in Philadelphia, Pennsylvania. Father Florio is a 1983 graduate of St. Joseph's Preparatory School. After completing his bachelor's degree in political science at Saint Joseph's University in 1987, he went on to work at his alma mater in the Division of Student Affairs while successfully earning a master's degree in training and organizational development in 1991. Later that year, he entered the Society of Jesus for the Maryland Province and began preparation for ordination to the priesthood. After professing first vows in 1993, he advanced to studies and earned a master's degree in philosophical resources from Fordham University, in New York City, in 1996. In 2001, he completed a Master of Divinity degree and a Master of Theology degree, with a concentration in pastoral studies, at the Weston Jesuit School of Theology of Boston College in Boston Massachusetts. He was ordained to the priesthood on June 9, 2001, in the Cathedral of Mary Our Queen in Baltimore Maryland. Father Florio successfully earned the degree of Doctor of Ministry in spiritual formation at the Catholic University of America, in Washington, D.C., in June 2013 and was also professed of his Final Vows in the Society of Jesus that same year.

After ordination, Father Florio served as the director of Campus Ministry at the University of Scranton from 2001-2005, as parochial vicar at St. Christopher's Church in Philadelphia from 2005-2006, and as the assistant to the vice president for Student Affairs at St. Joseph's University from 2006 to 2008. Additionally he served as the first Jesuit chaplain and director of the Newman Center at the University of Pennsylvania, from 2008 to 2010, while serving as an adjunct spiritual director at St. Charles Seminary in Philadelphia. He continues to serve as a spiritual director to priests, religious, seminarians and laity and has given numerous retreats, classes and lectures on Ignatian spirituality. He has also made several mission trips to El Salvador, where he has served the pastoral needs of a rural, underprivileged community. In August 2010, Father Florio joined the administration at Fordham University in New York City where, until 2015, he served as the assistant vice president for Campus Ministry and as the housemaster of the Manresa residential learning program. In 2015 he was appointed pastor and religious superior of Old Saint Joseph's Church in Philadelphia. In 2017 he was missioned to serve as the Provincial Assistant and Director of Vocations for the US East Province of the Society of Jesus. He served in this ministry for seven years and helped over fifty young men to enter the Jesuit novitiate. Father Florio continues to preside and preach in both English and Spanish in various parishes in New York City. He was recently missioned as the director of engagement and pastoral care (for donors) for the Province's Advancement Office.

In addition to his professional responsibilities, Reklaitis has been a tutor, mentor and member of the board of directors at the Washington Jesuit Academy, an all-scholarship middle school for underserved boys with an intense eleven hours per day, 11 months per year program centered on academics, life skills, resilience and spiritual development. He chaired the governance committee; developed reporting protocols and educational programs related to student safety; and crafted a sustaining agreement between the academy and the Maryland Province of the Society of Jesus. He was also an early member of the Woodstock Business Conference, a Jesuit organization created to integrate Jesuit discernment into business decisions.

Reklaitis has been on the Le Moyne College board of trustees since 2013 and served as chair of the board from 2019-2022; vice chair from 2016-2019; chair of the Governance and Succession Planning committees; and chair of the Ad Hoc Committees on Athletics and Strategic Communications. He was also the trustee member on the search committee for the athletic director.

Kent Syverud is the 12th chancellor and president of Syracuse University. During his tenure, the University has seen record applications and enrollment, attracting an increasingly diverse and academically accomplished student body.

The University has played a central role in Central New York's economic resurgence, including its work to attract Micron to the region. Chancellor Syverud previously served on Scouting's Longhouse Council, as Commissioner for the Middle States Commission on Higher Education, as co-Chair of the Regional Economic Development Council for Central New York, and as Chair of the Law School Admissions Council. In 2016, he completed six years of service as the Independent Trustee of the Deepwater Horizon Oil Spill Trust, the \$20 billion fund created by BP and the White House to manage claims related to the Gulf Oil Spill.
