

Physician Assistant

Per U.S. Federal Regulations, 34 CFR §668.14 and §668.43, the following disclosures related to the educational requirements for professional certification and licensure in New York State and other states and U.S. territories is provided.

Graduates of the Physician Assistant Program will be eligible to sit for the Physician Assistant National Certifying Exam (PANCE) that is accredited by the Accreditation Review Commission on Education for the Physician Assistant (ARC-PA). After successful completion of this exam, the graduate will be a certified Physician's Assistant. In addition, all states require licensure to practice; however, state licenses are usually based on the results of the PANCE certification examination. Le Moyne College has designed the curriculum that when successfully completed meets the educational requirements for professional licensure in New York State. Licensure information regarding other states and a good faith determination as to whether Le Moyne College's program meets the educational requirements of a respective state's licensure requirements are provided in the following table.
